Investment Objective

The objective of the Core Wealth 20/80 portfolio is to exceed the rate of inflation, as measured by Core CPI, by 2.00% as measured on a rolling 5-year basis. The comparative benchmark return is created using a hypothetical portfolio consisting of the following: 80% Bloomberg US Treasury Bellwethers 3 month Total Return Index, 13% iShares Russell 3000 Index ETF, 4% MSCI EAFE NR Index, 2% iShares MCSI EAFE Emerging Markets Index ETF, 1% Vanguard Real Estate Index ETF.

Strategy Notes

The Almega Wealth Management Core Wealth 20/80 portfolio targets an asset allocation of 20% equities and 80% fixed income. It's target asset allocation is broken down as follows: 13% US equities, 4% international equities, 2% emerging market equities, 1% US REIT securities, and 80% short-term fixed income instruments. The portfolio primarily invests in ETFs and US Treasury securities. The portfolio employs an opportunistic rebalancing strategy.

The Almega Core Wealth 20/80 Portfolio allows a +/- 20% drift from its asset allocation targets.

Almega utilizes a tiered fee schedule. Our stated investment management fee schedule is as follows: up to 1.00% on the first \$5 million in client assets under management, 0.50% on the next \$5 million in client assets under management, and 0.25% on all client assets under management above \$10 million. Actual investment advisor fees incurred by clients may vary.

The inception date of the portfolio illustrated in this report is displayed on the front page of the report. Almega does not have a stated minimum account size for inclusion in composite performance reports. Since inception, significant cash flow policy requires the temporary removal of any portfolio incurring cash inflows or outflows greater than 5% which impact performance from the composite for at least the month of the significant inflow or outflow.
