## Investment Objective

The objective of the Almega Core Wealth 80/20 portfolio is to exceed the rate of inflation, as measured by Core CPI, by 4.50% as measured on a rolling 5-year basis. The comparative benchmark return is created using a hypothetical portfolio consisting of the following: 20% Bloomberg US Treasury Bellwethers 3 month Total Return Index, 54% iShares Russell 3000 Index ETF, 17% MSCI EAFE NR Index, 7% iShares MCSI EAFE Emerging Markets Index ETF, 2% Vanguard Real Estate Index ETF.

## Strategy Notes

The Almega Core Wealth 80/20 Portfolio allocates 80% of its holdings to equity securities. It's target asset allocation is 54% US equities, 17% international equities, 7% emerging market equities, 2% US REIT securities, and 20% to fixed income instruments. The portfolio primarily invests in ETFs and short-term US Treasury Bills. The portfolio employs an opportunistic rebalancing strategy.

## Risk Management Notes

The Almega Core Wealth 80/20 Portfolio allows a +/- 20% drift from its asset allocation targets.

The 3-year annualized standard deviation measures the variability of the composite gross returns and benchmark returns over the preceding 36 month period, and is presented when the composite has 36 months of returns. Almega utilizes a tiered fee schedule. Our stated investment management fee schedule is as follows: up to 1.00% on the first \$5 million in client assets under management, 0.50% on the next \$5 million in client assets under management, and 0.25% on all client assets under management above \$10 million. Actual investment advisor fees incurred by clients may vary.

The inception date of the portfolio illustrated in this report is displayed on the front page of the report. Almega does not have a stated minimum account size for inclusion in composite performance reports. Since inception, significant cash flow policy requires the temporary removal of any portfolio incurring cash inflows or outflows greater than 5% which impact performance from the composite for at least the month of the significant inflow or outflow.
